A. Plantation of more trees:

Following the recommendations of the external experts of the Green Audit and Energy Audit Committee as reflected in the Green Audit and Energy Audit Report for the AY 2022-2023, Government General Degree College has intensified the drive for plantation of more trees within its campus. The college has received a supply of 200 plant saplings from Divisional Forest Officer, Kharagpur Division, Paschim Medinipur, West Bengal on the occasion of Van Mahatsav and the mentioned saplings were planted in the college campus by the teachers and students with great enthusiasm on 24.07.2023. Besides, college has expanded its butterfly garden and medicinal plant garden on the occasion of Van Mahatsav plantation drive on 15.07.2024.




Figure 3: Requisition letter for supplying saplings from Divisional Forest Officer, Kharagpur Division, Paschim Medinipur, West Bengal on the occasion of Van Mahatsav for plantation at Government General Degree College, Keshiary

C. Repair and maintenance of water pipelines:

Government General Degree College, Keshiary had sought allocation from the Department of Higher Education, Government of West Bengal for repair and maintenance work of its toilets and plumbing work to minimise the loss of water. Accordingly, the college had received allocation of *Rs.9,77,933/- (Rupees Nine Lakh Seventy Seven Thousand Nine Hundred Thirty Three only)* only for the repair and maintenance work executed by the P.W.Dte., Social Sector, Midnapore Division. The repair and maintenance work has mended the sanitary and plumbing faults of the college and has prevented loss of water. The documentary evidence of the mentioned repairmaintenance work is reflected in Figure 6 A, B.

D. Repair and maintenance of electrical installations:

Government General Degree College, Keshiary had sought allocation from the Department of Higher Education, Government of West Bengal for repair and maintenance work of its electrical installations. Accordingly, the college had received allotment of *Rs.4,39,441/- (Rupees Four Lakh Thirty Nine Thousand Four Hundred Fourty One only)* for the repair and maintenance work executed by the P.W.Dte., (Electrical), Social Sector, Midnapore Division. In the mentioned work, many of the CFL tubes have been replaced with LED tubes as recommended by the Green Audit and Energy Audit Committee and reflective in the Green Audit and Energy Audit Report for the AY 2022-2023. The action is deemed to reduce electrical consumption of the institute and reduce carbon emission. The documentary evidence of the mentioned repair-maintenance work is reflected in Figure 7. Moreover, the college has received approval for AMC of Electrical Installations amounting *Rs.5,19,362/- (Rupees Five Lakh Nineteen Thousand Three Hundred Thirty Three Sixty Two only)* from the Government for year-long maintenance of the electrical installations which is now operational in the College (Figure 8).

E. Disposal of plastic waste:

Government General Degree College, Keshiary has communicated the BDO, Keshiary Block, Paschim Medinipur for disposal of plastic waste generated within the campus on regular basis (Figure 9). The BDO, Keshiary Block has initiated steps to accomplish the mentioned request at the earliest.



Pathogenecity of bacterial growth:

Since bacterial growth was found in MPN test in sample T1 and T2 but no gas production, it was further analysed to check pathogenecity of the bacteria. The samples were inoculated on the Blood Agar media and allowed to incubate for 48 hrs.

The bacterial growth does not produce a hemolytic zone, hence no change to the RBCs, and the medium remain opaque red. This lack of hemolysis infers that the **bacteria are not pathogenic** and harmful.

Chlorine content:

The amount of chlorine was determined in three water samples and found to be as follows -

- 1. Tapwater 1 [T1] 0.6mg/l
- 2. Tapwater 2 [T2] 0.5mg/l

3. Filtered water [FW]- 0.2mg/l

Analysis of the results -

Routine surveillance of drinking water supplies should be carried out by the relevant authorities to understand the risk of specific pathogens and to define proper control procedures.

1. The pII of the water samples were found to be suitable for consumption.

2. The MPN analysis showed some bacterial growth in Tapwater but no growth at all in filtered water. This showed that the filtered water is most suitable for consumption. However the bacteria found in Tapwater were found to be non-pathogenic, as they do not exhibit any hemolysis on Blood Agar medium.

3. The chlorine content were a little higher in Tapwaters due to chlorination done in water supply. However it was reduced in filtered water making the filtered water fit for consumption. All the results therefore shows that the filtered water can be classified as the **Potable water** fit for consumption.

Suggestions:

 A regular analysis with an interval of 6-7 months should be carried out to have a routine reporting of the year.

Few other biochemical tests like dissolve oxygen, biochemical oxygen demand, phosphate and nitrate should be analysed, if possible.
