**LALLA JHINDA RAM-** A CONTRACTOR BY PROFESSION. FIVE FOOT TALL WITH AN OBESE. MASTER OF THE HOUSEHOLD AND AN AUTHORITARIAN FIGURE.

#### **SUKHI-** 50 YEARS OLD WOMAN

**SHAKUNTALA**- 25 YEAR OLD WOMAN. FROM A STATEMENT OF SUKHI, IT WAS CLEAR THAT SHAKUNTALA DID NOT BRING ANYTHING FROM HER HOME IN THE NAME OF DOWRY WHEREAS SUKHI BROUGHT A LAKH OF RUPEES. THIS IN TURN SHOWS THE DEPENDENCE OF WOMEN.

#### **PLOT OVERVIEW OF TWO LADY RAMS**

IN TWO LADY RAMS ANAND PRESENTS WITTY NARRATIVE OF LALLA JHINDA RAM'S HOUSEHOLD WHICH IS AT A CONSTANT STATE OF COLD WAR BETWEEN THE TWO LADY OF THE HOUSE SUKHI, THE ELDER WIFE AND SHAKUNTALA, THE YOUNGER. THE PLOT REVOLVES ROUND THE TWO WIVES

AN UNSAID ROUTINE WAS FOLLOWED BY LALLA JHINDA RAM. HE USED TO SLEEP WITH EACH OF HIS WIVES ON ALTERNATE DAYS AND PAID EQUAL ATTENTION. BUT THE MAYHEM STARTED UPRISING ONCE AGAIN WHEN LALLA JHINDA RAM WAS AWARDED KNIGHTHOOD AND WAS INVITED TO THE GARDEN PARTY ALONG WITH LADY RAM.

HOWEVER, THE READERS MISS TO NOTICE THAT THE SECOND WIFE TOO HAS BEEN DEPRIVED IN CERTAIN WAYS.IT IS ASTONISHING THAT A WOMAN WOULD BE WILLING TO MARRY AN ALREADY MARRIED MAN WHO IS MUCH OLDER THAN HER. **COMMODIFICATION OF WOMAN**.

- **3. MISUSE OF POWER-** ANOTHER THING TO BE NOTICED IS THAT LALLA JHINDA CAN EASILY ALTER THE LETTER AND THE RULE ACCORDING TO HIS WILL BCOZ HE HAS THE POWER AND MONEY TO DO SO. THIS FACTOR POINTS OUT THAT IRRESPECTIVE OF ERA OR TIME POWER ALWAYS HOLDS THE HIGHHHEEEST POSITION.
